**DECLARATIONS:**

1. I hereby declare that I am the owner/owner's agent of the animal(s) described above.
2. I further declare that all prime lambs/hoggets in this consignment have been mouthed during the past 48 hours and none have scaled up a permanent incisor. In the event that any sheep in this consignment are subsequently discovered within 2 working days of the sale to have erupted a permanent incisor then I will be liable to recompense the purchaser an amount of half the value of the average price per head of the consignment, as recommended by the Livestock Auctioneers Association.
3. The stock has been examined and show no signs of any disease or condition that may affect the safety of meat derived from them.
4. The stock comes from a holding which has had no movement of FMD susceptible animals onto it in the 6 days prior to the Market, other than the permitted exceptions.
5. The movement is in accordance with the General/Licence Conditions.
6. The Vehicle has been fully cleansed and disinfected prior to loading of stock.
7. Sheep and goats on the holding are not under movement restrictions for animal disease or public health reasons.
8. Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals while on this holding and previous holdings.
9. No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
